Disclaimer:

- Orders damaged by factors outside of Mountain Blue Farms' control such as flooding, frosts and bush fires shall be subject to negotiations on a case by case basis
- Once the order form has been signed, you are stating that you agree to the terms and conditions
- We reserve the right to refuse any order placed by any person, corporation or entity, at any time
- If an order is cancelled by the purchaser, MBF reserves the right to refuse refund of the deposit
- Should the purchaser wish to modify an order, this will need to be negotiated on a case by case basis
- Should MBF be unable to fulfil all or part of any order, we will be happy to cancel all or part of the order with your deposit refunded
- We welcome order pickups from MBF with the appropriate amount of notice given otherwise delivery schedules and costs will be negotiated on a case by case basis
- Once an order has been received, the purchaser has 48 hours to address any issues regarding plant health or order miscalculations. After the 48 hours MBF will assess on a case by case basis
- Quarantine issues restrict MBF from delivering plants to certain regions in Australia. Should an unforeseen Quarantine issue arise after an order has been made, MBF reserves the right to cancel or amend the order accordingly
- Payment Schedule for all orders is as follows: 20% Deposit on Ordering—80% Final Payment at Delivery
- Ridley 1111 (OPI) is a proprietary PBR recognised variety owned by MBF. There is a minimum order of 500 plants with a royalty cost of \$4.40 (including GST) per plant. A non-exclusive, non-propagation agreement is to be signed prior to collection of the plants.
- The following conditions for all deliveries apply:
 - An additional unload fee will be charged at \$45.00/hour if minimum labour of 2 people is not supplied by the grower
 - Maximum 5 drop off points per truck load of plants
 - MBF will not take responsibility for the removal of any waste including plastic pots or trays
 - All deliveries are subject to availability of MBF trucks and drivers.
 - The delivery date is non-committal unless expressly fixed in the written confirmation of order.
 - Should the buyer not fulfil the above payment obligations, the seller has the right to suspend delivery
 - Risk of incidental loss or accidental deterioration or damage of plants passes to the grower at the moment the plants are taken from the truck
